In consideration of being accepted with an invitational entry to the 2022 Team BTEO Falmouth Road Race, I agree to raise a minimum of \$1,000.00 for Belonging To Each Other. The deadline for BTEO to receive the minimum fundraising amount of \$1,000.00 is July 31, 2022 (unless extended by BTEO). Belonging To Each Other policy states that if the \$1,000.00 fundraising requirement has not been received before July 31, 2022, BTEO can charge the credit card linked to my Race Roster account. I hereby authorize BTEO to charge any balance due after 7/31/2022.

REGISTRATION AGREEMENT

I understand that, if I am selected to receive an entry on Team BTEO, that Belonging To Each Other, a charity supporting Falmouth people experiencing homelessness, has paid on my behalf the \$200 registration fee required by the Falmouth Road Race. In consideration for my agreeing to raise the minimum fundraising requirement, BTEO is not asking me to reimburse Belonging To Each Other for this expense.

I agree to notify BTEO immediately via email if I believe I will be unable to raise the minimum fundraising requirement by the July 31, 2022 deadline (as extended at BTEO’s discretion). If I cannot raise the minimum fundraising requirement by that deadline date, my registration to the Falmouth Road Race may be cancelled by BTEO without notice or refund of amounts raised.

LIABILITY WAIVER
