As this is being written, Belonging to Each Other (BTEO) has just opened its transitional housing program for Falmouth people experiencing homelessness for the 9th time (bteofalmouth.com/roomier-rental/). We already have 12 of our 16 available beds occupied and the remaining beds will be filled soon. Our new residents are thankful for a place of respite and the opportunity to change their lives. They are starting to work with Carol Greeley our program and clinical director, and Brittnay Maley and Jackie Soronson our case managers, on housing stability plans. A trilingual, second-year social work intern has joined the team this year. You can learn more about the staff and programs we offer inside this newsletter.

BTEO has a lot to be thankful for this year. We are thankful for last year's 82 volunteers and for the new volunteers who set up our houses, provide meals and transportation, and help with events and appeals to fund our operations. We appreciate every donation of money, supplies, time, and talent. And we are deeply grateful for the rewarding opportunity to work with our Falmouth neighbors on their journey from their tents, cars, and the woods to stable housing. Witnessing our neighbors' growth and the change in their situation is deeply gratifying to all who participate.

BTEO as an organization is also growing and transforming. As you can see from this Impact Report, BTEO continues to evolve as a nimble organization focused on the needs of our most vulnerable neighbors. We have deepened collaborations with other local organizations to serve the homeless neighbors and the recently re-housed in a manner



### 2023-2024 Season Kicks Off at the BTEO Men's and Women's Houses

In November, thanks to our **amazing team of volunteers**, seven women and five men moved into our two completely furnished houses and began the next stage of their journey to an apartment of their own.

Our 12 Falmouth neighbors have connected with our case managers to begin developing their individual housing plans and will continue this work while they live with us in addition to addressing other needs, including employment search and access to health and mental health care.

We are fortunate to have our **two case managers** Brittnay and Jackie for their extensive expertise in recovery and housing, and for first time BTEO welcomes a second year Masters of Social Work intern, Viviane Da Silva Almeida.

New and expanding this year are partnerships with **Sharing Kindness**, **Independence House**, **and Falmouth Human Services** to provide supportive groups to the men and women while they are our guests. We hope this new aspect of programing will build individual skills and community connections that our residents will carry with them when their stay with BTEO is over.







## Alumni Client Story - Hard work pays off

Homeless Outreach Team referred Emily\* to us when they found her living in her car, which she moved between different locations around town. At 67, she had been through tough times and felt she could not spend another winter in her car. She is a life-long Falmouth resident - her parents, grandparents and even her great grandparents called Falmouth home. Like many on the Cape, Emily had to leave her apartment when her landlord planned to sell the house. Emily was scared and overwhelmed and spent the year couch surfing, returning to her car when she worried she had imposed long enough on her friends and family.

Finding an apartment or room that she could afford based on her Social Security and part time job was impossible. With the help of our community partners, Emily moved into BTEO last year and worked hard to complete as many housing applications as she was eligible for. In April 2023, she was at the top of the Senior Housing list and received the call that an apartment was open. Emily has been in her apartment for 6 months and finally feels she is in a place of her own. As part of our Community Assist program, we will follow her for the next two years, checking in and offering support when she needs it.


